1. For the Post of Chief Marketing Officer

- (i) **Qualification** : Master's Degree in Agriculture/Commerce/Economics, Preference will be given to M.B.A.
- (ii) **Experience** : Candidate must have 15 years experience in highly reputed Institution/Organization of Seed Marketing, Fertilizers. Preference will be given to candidate having specialization in Marketing of Agriculture produce, and Sale/Procurement/Trading of Agro products including one year experience in the pay scale of Rs. 15600-39100 Grade pay Rs. 7600 or equivalent pay scale.
- (iii) In Condition of Contractual basis recruitment fixed remuneration for the post of Chief Marketing Officer would be Rs. 90,000.00 per month.

2. For the Post of Joint Chief Marketing Officer
